Sub: Matter related to representation dated 18/12/2021 from Sendhwa Homoeopathic Medical College & Hospital, Dist. Barwani, Sendhwa- 451666. Madhya Pradesh for continuing admission in (Ist BHMS) course with intake capacity of 100 seats for the academic session 2021-22-reg.

Sir/Madam,

This has reference to your representation dated 18/12/2021 to the Commission against the denial letter passed by Medical Assessment and Rating Board (MA&RB) vide its letter dated 06/12/2021. The submission made through representation dated 18/12/2021 to consider the required documents/information pointed out while granting the permission for student intake of 100 seats in I-BHMS course for the academic session 2021-22 has been carefully examined by the Commission and observed the following:

Submission of College to Commission:

Observations of Hearing Committee & MA&RB vide letter dated 06/12/2021 mentioned that *Hospital Staff; Dr. Kousar Iqbal Sheikh, BHMS, Obstetrician, Ms. Madhuri Gopal Dhaybar, B.A. DMLT, Pathologist- has not having requisite qualification; Account Staff, Cleanliness Staff not provided for verification; Yoga expert cannot be considered eligible as qualification document not provided for the verification; Dietician Not considered available as no document is provided for verification; Watch man – Documents are not provided for verification*

College submitted appointment letter, Joining letter for Dr. Dinesh Agrawal MBBS, DGO (Consultant Obstetrician& Gynecologist on 02/08/2021), Dr Mohammed Asif, MD (Pathology on 01/07/2021), (Account Staff), Shubhangi Mehre (Yoga expert) holding qualification of Diploma in Yoga Shikshak, Yashwantrao Chavan Maharashtra Open University, Nasik, Dr Shiram Mandloi, Associate Professor, (Community Medicine, no dietician in rural place like Sendhwa); Contract papers of watchman Shri Harishchandra Singh Chauhan & New nursing staff (Ankita Nargawe & Uma Dudve).

Observation

Now, the college vide its appeal letter dated 18/12/2021 has submitted the details of the following Hospital Staff :

- i. Dr. Dinesh Agrawal MBBS, DGO as Consultant Obstetrician& Gynecologist on 02/08/2021
- ii. Dr Mohammed Asif, MD Pathology on 01/07/2021.
- iii. Documents of Account Staff
- iv. Shubhangi Mehere, Yoga expert holding qualification of Diploma in Yoga Shikskak (Yashwantrao Chavan Maharashtra Open University, Nasik)
- v. Dr Shriram Mandloi, Associate Professor, Community Medicine(Dietitian)
- vi. Contract papers of Shri Harishchandra Singh Chauhan (watchman)
- vii. New nursing staff (Ankita Nargawe & Uma Dudve)

Commission examined these documents and observed that new nursing staff namely, Ankita Nargawe (RN&RM) and Uma Dudve (RN&RM) posted on 08/12/2021. This is done after Virtual Hearing held on 01/11/2021. Hence appointments are not acceptable. Commission observed that during Virtual Hearing held on 01/11/2021 documents (i) to (vi) were not considered even though these documents were submitted to MA&RB vide email on the same day. Therefore, these documents are acceptable. College appointed required staff as per Schedule II, MSR,2013.

Submission of College to Commission:

Observations of Hearing Committee & MA&RB vide letter dated 06/12/2021 mentioned that *USG availability cannot be ascertained as no document is provided for verification. IPD diet register not provided in Part-1. Submitted diet register is not in the proper format*

College submitted MOU with Sant Shiromani Shri Narayandasji Hospital and diet register for the hospital.

Observation

Commission examined MOU with Sant Shiromani Shri Narayandasji Hospital and diet register submitted by the College. Both found satisfactory. Hence this point does not exist.

Submission of College to Commission:

Observations of Hearing Committee & MA&RB vide letter dated 06/12/2021 mentioned that *ineligible Teachers; Physiology - Dr. Nilima Hemant Pawar, B.H.M.S. Cannot be considered eligible as per MSE age exceeded 35 years (Joined on 01.03.2013) not eligible as per MSE. Dr. Geeta Vishnariya, FMT (Lecturer) cannot be considered eligible as no document provided for verification. Obstetrics and Gynecology: Dr. Dilip Bhagwandas Kadam, (Professor, OBG) cannot be considered as Professor as having less than 10 years teaching experience for Professor (As per MSE 1983); Repertory-Dr. Mahesh Kaluram Desale, cannot be considered as eligible not having 3 years teaching experience as demonstrator as per MSE 1983; Dr. Mohan Gopal Krishna Pandey, cannot be considered as eligible as joined as lecturer on 10/01/2014 but do not have post graduation degree.*

College submitted relevant documents related to the appointment of teachers in Department of Physiology, Obstetrics and Gynecology, Repertory

Observation

Commission after examination, it is observed that College has appointed the following staff having enough experience:

- i. Dr Dipak Omprakash Singh instead of Dr. Nilima Hemant Pawar in Dept. of Physiology and submitted appointment& joining letter dated 31/08/2021

- ii. Documents of Dr Mohit Bundela, Assistant Prof., FMT joined on 01/01/2021 instead of Dr. Geeta Vishnariya, FMT (Lecturer)
- iii. Experience certificate of Dr. Dalip Kadam, Obstetrics & Gynecology
- iv. Experience certificate of Dr. Mahesh Kaluram Desale substantiating sufficient experience

These documents and found satisfactory. Hence this point does not exist.

Submission of College to Commission:

Observations of Hearing Committee & MA&RB vide letter dated 06/12/2021 mentioned that *Part Time Teachers (09): No documents of 07 part time teachers provided for the verification*

College submitted the relevant documents regarding appointment of Ophthalmologist, Gynecologist, Radiologist, Anesthetist, Ophthalmologist, Dentist and Pediatrician as part time.

Observation

Commission verified the supporting documents for 07 part time teachers of the college viz. appointment letter, joining letter, qualification certificates, registration certificates etc. Ophthalmologist, Gynecologist, Radiologist, Anesthetist, Ophthalmologist, Dentist and Pediatrician are available as part time. However, Ophthalmologist & Dentist submitted Consent letter without date. Consultants of modern medicine required for the College as per 9(2) of MSR, 2013 is available in the College. Hence the point does not exist.

Overall observations:

1. Observations of Commission based on the submission made vide letter dated 18/12/2021 by Sendhwa Homoeopathic Medical College & Hospital, Dist. Barwani, Sendhwa, Madhya Pradesh have been carefully examined as per the provisions of the Homoeopathy Central Council (Minimum Standards Requirement of Homeopathic Colleges and attached Hospitals) regulations, 2013 and the relevant regulations made there under and it is observed that the College has rectified the deficiencies pointed out by the Hearing Committee and MA&B vide letter MA&RB) vide its letter dated 06/12/2021 particularly staff available in the College.

2. In view of the aforesaid observations and compliance in term of regular faculty, Commission decided to grant permission for 100 seats in BHMS course at Sendhwa Homoeopathic Medical College & Hospital, Dist. Barwani, Sendhwa, Madhya Pradesh for the academic session 2021-22.

3 Accordingly, your representation dated 18/12/2021 received to Commission against MA&RB letter dated 06/12/2021 stands disposed off.
